8. Overview of the Caribbean Hotspot Project

The Critical Ecosystem Partnership Fund (CEPF) Caribbean Islands Biodiversity Hotspot Small Grants Mechanism is being implemented in the Caribbean Islands by the Caribbean Natural Resources Institute (CANARI) acting as the Regional Implementation Team (RIT). After a successful first investment in the Caribbean Islands Biodiversity Hotspot between 2011 and 2016, the CEPF has returned to the region for a second phase of investment from August 2021 – July 2026, which totals US\$11.8 million.

The goal of the CEPF is to conserve biodiversity. Its approach is to build local conservation leadership and nurture sustainable development by developing locally driven conservation strategies and providing grants to civil society to implement those strategies. In the Caribbean, the CEPF aims to strengthen the protection and management of globally important biodiversity within 32 priority Key Biodiversity Areas (KBAs) and seven conservation corridors in Antigua and Barbuda; The Bahamas; Dominican Republic; Haiti; Jamaica; Saint Lucia; Saint Vincent and the Grenadines.

9. Project Components

This sub-project seeks to improve the conservation-enabling environment of the Pointe Sable Protected Area (PSEPA) through two main components (i) Supporting the establishment of an enabling policy and management framework for protected areas (PA) at the national level and (ii) Assessing and strengthening SLNT's PA management and capacity needs with particular focus on sustainable management and conservation of the PSEPA.

10. Risks to community health and safety and mitigation measures

There are a few anticipated risks to community health and safety for this project, with those identified listed below in Table 10.1.

12. Measures to avoid risk of COVID-19

Any other relevant guidance from the World Bank as outlined in the technical note, "Public Consultations and Stakeholder Engagement in WB-supported operations when there are constraints on conducting public meetings" (March 20, 2020)¹ will be followed, as relevant and appropriate.

Like many public and private sector agencies, the Saint Lucia National Trust developed a COVID-19 Response plan during the pandemic. The Trust plan can be accessed via this link (https://ldrv.ms/w/s!AhaFtaV-HymMjTh6S2i8p5llpRPD?e=Gd7wGF. Saint Lucia removed all requirements for testing for visitors in February 2023, but COVID-19 transmission may still be a risk within the Saint Lucia National Trust amongst employees throughout the duration of the project. It may also be a risk to stakeholders at consultations. Therefore, to minimize the risk of transmission, proper signage around the Trust office will remain in place, with additional signs if needed. This signage reminds people (employees and visitors) to wash hands frequently, sanitize, social distance, and wear masks. Seating will be arranged to ensure social distancing during consultations. People who report sick will be encouraged to stay home or seek medical attention, if their condition is serious. Contact with suspected infected persons will be avoided.

13. Emergency preparedness and response plan Inclement Weather

- 1. Alert all employees of the weather conditions, and ask for a status update on whether they are in a safe location.
- 2. If they are at home and are able to work remotely, they should do so until notified that it is safe to travel.
- 3. If they are at a job site, they should find a safe location to wait until it is safe to travel again.
- 4. Locate any necessary emergency equipment or supplies if it is necessary to wait for an extended period of time.

Hurricanes

- 1. Alert all employees of the approaching storm.
- 2. Secure the facility (boarding up windows, removing outdoor furniture, etc.).
- 3. If necessary, stop all work and send employee's home.
- 4. Follow any and all local evacuation orders from authorities.
- 5. When it is safe, return to the facility to assess the damage and coordinate recovery efforts.

Earthquakes

- 1. During an earthquake, employees should pull over, stop and set parking brake.
- 2. If employees are outdoors, they should stay away from buildings.
- 3. If indoors, employees should stay put and not run outside.
- 4. If trapped, one should send a text or bang on a pipe or wall.
- 5. Employees should check themselves to see if they are hurt and help others if an employee(s) has certified training in disaster recovery.

14. Measures to mitigate risks relating to security personnel

The SLNT rangers have an important environmental responsibility to patrol protected areas, monitor wildlife, record illegal activities such as poaching, and to engage local communities in conservation. In order to avoid unlawful acts against local people, rangers will abide by SLNT standards to ensure professional behaviour and to act with justness and sincerity at all times. They will undergo conflict management training once every six (6) months.

15. Timeline and resources

The implementation of mitigation measures will occur throughout the entire project time frame. The cost of implementing the plan is mostly included in the CEPF project.
