Impact Description	Impact Summary
A decrease of destructive fishing activity at Atauro Island.	The majority of local community in Atauro Island, especially fishermen, have been understand negative impact of destructive fishing on their coastal and marine resources. Some of them even pushed to established MPA as soon as possible to protect their coral reef and fish habitat.
• An increase in fish biomass from the baseline data (target to be set – c10%). Regular monitoring (biodiversity and socio-economic) will be undertaken to monitor changes over time.	The baseline data based on biophysic survey under the project showing that the live coral cover in Atauro Island 55% and fish biomass 336,8 kg/hectares. In the long term, need an annual monitoring on coral reef, reef fish and other key marine habitat dan biota to know the trend of condition. The datas can be an evaluation and monitoring inputs on MPA management effectiveness. In long term management plan, the target for coral reef and fish biomass increasing 10% in 10 years and 20% in 20 years. For the socioeconomic monitoring, in the long-term management plan, within 20 years the result of capture fisheries increasing 15% for 20 years.
• An increase of live coral cover from the baseline data (target to be set – c15%).	The baseline data from Biophysic survey showing the live coral cover of Atauro Island 55% in 2017. In the long term management plan, the target of MPA, increasing the live coral cover 10% within 10 years and 20 % within 20 years. The annual reef health monitoring will be needed to know the trend of coral reef condition.

- Using simple language (local language) important to explain about MPA concept and its benefit for local community
- Visual medias to delivery coastal and marine conservation messages more effective comparing with presentation and paper.
- Carefully study on others planning and project in the similar project location is important to avoid contra-productive process and result

- Included the local community fishing ground into sustainable fisheries zone where the community allwing to do fishing as long as not using destructive fishing method and fishing protected marine animal
- Increasing knowledge and skill of community and government on MPA basic principle and design through trainings and outreach materials production (posters, movies, presentations)

The Action taken related with the environment safeguard:

- Ecology data collection through surveys with acknowledge scientific methodologies and protocols.
- Identification interest area and determination clear conservation target to makesure management focus included resoruces allocation
- There is no DNA or sampling on the marine ecosystem/animal
- Avoid using single use plastic for meetings, workshop and field activity related with the project

Two years project sufficient only for MPA establishment processes (depend on with the complexity). IThe project will need to be continue to the next level in term of support the management unit to manage the MPA such as strengthening the management unit capaicty, provide monitoring protocol as well as other protocol needed and its implementation, support on surveillance and patrol, continue outreach and education, as well as implementing of sustainable financing mecahnism.
