PART I: Overview

1. Implementation Partners for this Project (*list each partner and explain how they were involved in the project*)

Partners

National Park Galicica - their tasks: They were involved in the mapping of all illegal landfills in the territory of the NPG, then they were involved in the trainings that we carried out by hiring trainers, they were involved in the Leave no trace (LNT) trainings and all of that was supposed to continue even after the end of the project. They were part of key meetings with local stakeholders in order to introduce standards that were accepted with the METT tool, but this is still not implemented on the ground. They accepted our annual program and action plan of the organization.

Stakeholders

Red Cross – We decided to cooperate with CK as one of the key ones, precisely because of the fact that a large part of young people who are actively involved in volunteerism, should receive training on LNT and then pass it on to the rest of the volunteers and their friends.

Mountain Risqué Unit from Ohrid - The cooperation with the mountain rescue service is of crucial importance for the realization of our activities. These were invited in order to create an agreement/body within the NPG - which would establish minimum safety criteria for the operation of adventure tourism providers (and apply to service providers in the South West region).

Sector for local economic development and tourism - we agreed with this institution to jointly create adventure products, which will be promoted at international fairs, to work for the affirmation of Ohrid and Macedonia, and NPG was supposed to be the host of these activities/meetings

Faculty for tourism - we agreed with this institution to make a selection of staff who will work in the area of adventure tourism and through real examples to get acquainted with the new services offered by tourism as a branch. And for this NPG should launch an initiative.

Adventure tourism service providers - with all of them we organized a meeting where we completed and approved the METT tool intended for NPG and thus agreed that in the future we will cooperate more in the area of implementation of standards that will apply to all of us in adventure tourism, of course if we want to work in the territory of NPG.

Local communities - we discussed waste problems with these communities, we also conducted a survey, and from that survey emerged the reasons why we have the occurrence of illegal landfills in NPG territory.

2. Summarize the overall results of your project

From 14 till 17 of December we had a 4 day workshop where we prepare strategic documents and planning for Explorer Mk – Together with our Consultant - Bojan Rantasha.

Our second workshop for conflict solving issues in tourism was organized in 2 days from 10th till 11th of February – together with 2 trainers. We choose them on official procedure.

There were many meetings with local stakeholders from region around Ohrid, with which we increase our collaboration (TLER form Ohrid Municipality, National Park Galicica, Comunal Department from Ohrid, Faculty for Tourism and Hospitality and previously we alredy have established collaboration with PSS Ohrid and Red Cross from Ohrid) but in same time we try to finalize with all project activates. One of them, which is crucial in this moment is bulky waist container. For that reason we are in process of signing memorandum of understanding with Communal Department and NP Galicica + Local Municipality from Ohrid (because all local communities are under local government responsibility).

Memorandum of understanding between NP Galicica, Communal Department and Explorer has been signed.

Our Third Workshop was organized in the head office of NP Galicica, where we have both experts (Anela and Bojan) + local providers from Ohrid and together we was working on MEET tool in the part where Tourism is involved

We send team of Volunteer's for field's visits in this villages: Ramne, Velestovo, Elshani, Upper Konjsko, Trpejca, Ljubanista. First to find all places where locals are throwing garbage and second to see if this places are achievable by the tracks of Communal Department and third reason is the land ownership (we were making research if all this places are privat or property of the state – Macedonia. After this research we are in final stage to start with our works with the Container for bulk waist. Our volunteers have meetings with local people and their local communities (in some places they still exist)

We organized training with international trainer and 2 national trainer on which we provide knowledge for LNT practices. With this training we educate 12 trainers from Macedonia (national trainers) and their job was to organize 4 to 5 trainings with organizations, clubs, NP Galicica and his friends organizations.

As the most important from this project Explorer has increase its collaboration with many institutions, as: Mountain /Rescue unit from Ohrid, Red Cross from Ohrid, Tourism and Local Economic Development – par of our Municipality, Communal Department and many NGO's, but the most interesting is this info: Communal Department and NP Galicica (both from Ohrid) are open for joining collaboration and participation on extension of this project and we will submit joint funding applications including to PONT.

2.2	Organized workshop for 20 participants (guides and Park guards) on improving communication and conflict resolution skills.	This training was organized in Hotel Belvedere Ohrid. Oficial trainer was Ljupka Ristevska and on this training we had representatives from Explorer and NP Galicica. Our main goal through this training was for all service providers and park employees who are in constant communication and contact with tourists to get used to soft skills on how to communicate and how to resolve conflict situations. In this way, we will protect employees from educated tourists who sometimes do things with the intention to harm our mood and thereby devalue our work/engagement
3.1	Organized training in Leave No Trace for 20 guides from Ohrid and Prespa area.	In Village Velestovo – old primary school we organized training for LNT. Official international trainer was Jack Delf from Montenegro. This training was attended by members from Explorer, NP Galicica and other local stakeholders (providers of services in adventure tourism. All those who received a trainer certificate committed to carry out several volunteer trainings at the invitation of NP Galicica (and it was completed in cooperation with Angela Taseska from NP Galicica).We have joining educational workshops in all primary schools in the territory of Ohrid and Struga.
3.2	Organized training in nature protection rules and regulations for 20 guides from Ohrid and Prespa area.	This training was held in the premises of NP Galichica. At this workshop, we learned about the activities of the park and what measures are taken to protect the flora and fauna, and two employees from the park spoke on this topic. Later, we reviewed practices from the World Tourism Organization, we analyzed our legislation in the area of active tourism, and on the second day we moved on to filling out the METT tool together and agreed that this practice will continue to be implemented once a year before sending the annual reports.
4.1	Organized at least 4 Leave No Trace workshops for 10 participants each, that will educate the participants and contribute to cleaning of the NPG.	Thanks to this project, 4 workshops were held where the volunteers together with the trainers were first introduced to the topic, and later they started cleaning the park. This type of action was seen to be of particular importance for the community, and the results and the desire to repeat the same are huge, especially among young people and parents (this fact is particularly gratifying). This workshops took place in different locations, such as: Velestovo (Red Cross and the children from the Erasmus program), Vevcani with the primary school, the village of Ramne in a joint action in which children and parents took part
4.2	Pilot examples for waste reduction implemented in urban and nature sites in NPG.	A team of 4 volunteers approached the realization of this project activity. They had as a task to survey all the villages along the territory of the national park from the Ohrid side (Ramne, Velestovo, Elshani, Gorno Konjsko, Trpejca, Ljubanishta). During the visit to each of these villages, the wild dumps were mapped, then they talked

and collected information from the locals who met them on the street, and with those villages where there are local communities, they also talked with the officials about solving the problem with bulky waste. A suitable location for the container was sought. After the realized field activity, a short report was made and according to the results, the village of Ramne was chosen as the pilot village where the container for bulky waste was initially
placed.

Professionals should be part of the network tool to monitor and correct volunteer observations.
